

# **Housing Application Form**

#### **Guidance Notes for Applicants**

These notes are provided as a basic guide to assist you with your application. By following this simple guidance, you will ensure that your application is assessed as accurately as possible and you are matched to accommodation which is most suitable for your needs.

- When completing this form, please use BLOCK CAPITALS, black ink and tick or circle the correct boxes. If you are not sure of the answer, tick the box you think is right and give an explanation in the spaces provided
- Please complete the form in full, answering all questions. The information you provide will be used to assess your application and determine your needs for housing according to our Housing Options Policy.
- This form is an application for all types of housing, therefore there may be some questions which may not apply to you. If this is the case, please tick "No" or write "not applicable".
- If any questions have not been answered fully, then this may delay your application being processed. We may even have to return the form to you. It could also mean that your application is not correctly assessed.
- Please provide further details where this is requested on the form.
- Please remember to take everyone into account when answering the questions.
- Once fully completed, the form should be signed, dated and returned to our office or by email at <u>enquiries@radcliffehs.org</u>.
- The form can only be signed by the applicant/s; if it is a joint tenancy, both applicants must sign.
- In signing the declaration at the end of the form, you are confirming that the information you have given is true and correct. You should be aware that if you provide false or misleading information then this could result in us withdrawing an offer of a tenancy.

### Confidentiality & data protection

• The information you provide in your form will be treated as confidential. It will only be used for the purposes of assessing your application and held securely.

### How is my application assessed?

- Your application will be assessed according to our Housing Options Policy based on the answers you provide in the form. This is why it is important for you to complete the form as fully and as accurately as possible, providing any additional information where requested.
- Should you wish to discuss any aspect of our Housing Options Policy or how your application will been assesses, please contact us.
- Our Privacy Notice is included with this application form, please keep it for your information and **do not** return it to us.

#### What happens next

- Once your completed application form has been returned it will be assessed and kept securely by us.
- You will receive a letter within 7 working days confirming the outcome of your application.
- You will join our waiting list if your application is accepted.
- Once a property becomes available, we will contact you to agree a date and time to view the property and we may ask you for additional relevant information.

#### **Re-assessments**

- We will write to you at least once a year to ask whether you wish to remain on our list. If we do not hear from you within 7 days of that letter or email, we will automatically remove your details from our list.
- You must keep us informed of any changes in your circumstances. If you move elsewhere and do not tell us, your application will be cancelled. If you apply again, your application will start as new.
- Before signing this form, please check that you have answered all the questions. If any answers are incomplete, it will delay your application.

#### How we use your personal information

- We will use the information you have provided in this form to process your housing application to determine your eligibility for housing and to ensure that any subsequent tenancy and support services are suitable for your needs.
- We have a duty to protect the public funds it administers and may use the information you have provided on this form, for the prevention and detection of fraud. We may also share this information with Housing Benefits, Housing Associations to whom you have been nominated and other bodies administering public funds, solely for these purposes.
- You have the right to request a copy of the personal information we hold about you and also to correct any inaccuracies in your information.
